1. Call to Order

3. New Business

- Bill No. 84.09 presented by Senator Viss
 - To eliminate positions in the SGA Executive Cabinet and create new positions with more focused objectives.
 - i. Discussion:
 - a. Senator Perkins moved to amend the bill under sections 1F, 2F, and 3E to strike out “Serve a term of one year” and insert “Serve until the end of the legislative session” so that the bill reads “Serve until the end of the legislative session in the position. Seconded.”
 - Amendment passed by majority vote.
 - b. Senator Logsdon moved to amend the bill in Chapter 6 under the Executive Cabinet to strike out “enrolled in at least 12 semester credit hours” so that the bill reads “Members of the executive cabinet must be full time students and maintain a 2.50 grade-point average.” Seconded.
 - Amendment passed by majority vote.
 - c. Senator Knox moved to insert the words “Marketing and” so that the bill reads “Department of Marketing and Publications.” Seconded.
 - Amendment passed by majority vote.
 - Senator Bennett called for previous question. Seconded.
 - i. Approved by 2/3 vote.
 - Vote to approve the proposed bill as amended.
 - i. Passed by majority vote.
- Bill No. 84.10 presented by Senator Viss
 - Amendments of Standing Committee requirements.

- i. Discussion
 - o Senator Perkins called for previous question. Seconded.
 - i. Approved by 2/3 vote.
 - o Vote to approve the proposed bill as written.
 - i. Passed by majority vote.
- Bill No. 84.11 presented by Senator Viss
 - o GPA and Experience Requirement
 - i. Discussion:
 - a. Senator Morris moved to strike out “for at least two long semesters” so that the bill reads “No person who has not served in the Angelo State University Student Government Association shall apply for President or Vice President.” Seconded.

 - a. Bill was not passed.
